The following is the eligibility rules for the WCA Ratings:  
Weimaraners that have disqualifying faults (as listed in the current standard for the breed) shall be eligible to compete for or receive ratings provided they are spayed or neutered. PRIOR to being entered in a ratings test, Weimaraners with disqualifying faults must be certified by the National Office as being spayed or neutered and receive a DQF Number. All Weimaraners with AKC ILP numbers are allowed to participate without applying to the National Office.

## **Directions:**

### **From points North:**

Take I-20 to Hwy 441 South (exit 114)  
Continue to Milledgeville (approx 40 miles)  
Turn RIGHT on Dunlap/Roberson Mill/Hwy 441 by-pass (@ mall),  
Continue on 441 by-pass 5.8 miles  
Turn RIGHT on Hwy 243 (@ 5th light). Continue 3.5 miles  
Turn LEFT on Register Road (@ Cooper's Community Water Tower)  
Grounds are .75 miles on the LEFT

### **From Points South:**

Take I-75 to Macon, Take I-16 East ("Savannah")  
Go 1 mile to Exit 1--Spring Street,  
Turn LEFT on Spring Street/Hwy 129  
Continue approx. 500 ft to RIGHT US 23/Emery HWY  
Continue on US 23 for 2.8 mi  
turn slightly LEFT onto US 80 that turns into GA 57 and GA 243  
Continue 21.5 mi turn LEFT onto Pennington Road/243  
Continue 3.5 mi turn RIGHT on Register Road (@ Cooper's church)  
Grounds are on left.75 miles
